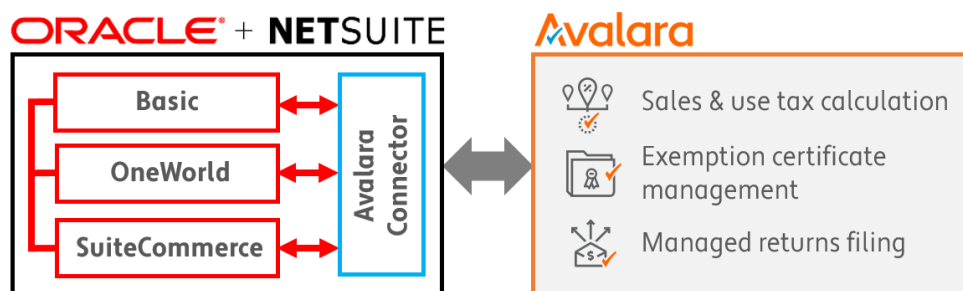

On-line, in-store POS, and mobile POS interfaces allow customers or store employees to easily look up existing certificates or add new ones simply by taking a picture of it with an app on their mobile device. Centralized storage and easy retrieval of certificates minimizes risk of audit failure.
